Acceptable Technology and Internet Use

In line with the Department of Education policy, the Geraldton Residential College has implemented the following guidelines:

- No technology devices are to be used in the dining room during meal times. Any student seen on their device during meal times will be asked to surrender the device to staff for the remainder of the meal.
- Any misuse of technology devices can result in removal after consultation with parents/carers.
- Students are to conduct themselves online in the same manner expected at the college (and in line with the college Code of Conduct).
- Internet access is monitored and filtered for misuse to ensure compliance with GSHS/GRC Network Usage Agreement and that of the Department of Education.
- Any breaches in acceptable online use may result in loss of internet access and/or surrendering of devices and may result in being held liable for any offences committed while using online services.
- Student passwords must be 10-character mix of lower, upper case and digits and cannot contain your name, or your schools name in any part, in line with Department of Education policy.
- The college accepts no responsibility for replacing lost, stolen or damaged electronic devices.

Technology Cabinet (Applies to Years 7-9)

- All Junior Students (Years 7 - 9) must place all their devices into the Technology Cabinet on Sunday-Thursday between 8:30 - 8:45pm and before 9:45pm Friday-Saturday, at the request of the supervisor.
- The Technology Cabinet is locked overnight and monitored by staff when students have access.
- Devices are returned to students the following morning once students have achieved room standards.
- Parents/carers of students in Years 10-12 may request their child surrender their devices overnight.

Gaming Devices

- Gaming Devices are only to be used in the common area.
- Gaming Devices can be collected from the Technology Cabinet from 3:00pm Friday for use through until Sunday 5pm.
- Gaming devices **MUST** be surrendered to the Supervisor and placed in the Technology Cabinet before 5:00 pm on Sunday.
- Only the student who brought the device may collect it from the Technology Cabinet. Any other student (inc. siblings) must have the permission of the student who brought it, or parent.
- Personal TV's/Monitors will not be allowed in the student's room, any exceptions are at the discretion of the Supervisory Team.
